Approve the recommendation to award the above Invitation to Bid (ITB). Contract Term: October 1, 2017 through September 30, 2020, 3 Years User Department: Physical Plant Operations; Award Amount: \$400,000 Awarded Vendor(s): Bliss Products and Services, Inc.; Olive Branch Products and Packaging, Inc.; Playmore West Inc., d/b/a Playmore Recreational Products and Services; School Specialty, Inc.; Schoolhouse Products, Inc.; Swartz Associates, Inc. SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida, received seven (7) bids in response to ITB 18-044T. This Bid will be utilized mainly by Physical Plant Operations (PPO). This manufacturer list catalog bid enables PPO to purchase a wide array of outdoor furniture. In addition to PPO, schools utilize this Bid to purchase outdoor furniture funded by the individual school's operating budget.
