REQUESTED ACTION:
Approve the additional spending authority. Contract Term: July 12, 2012 through July 12, 2020, 8 Years; User Department: District-wide; Additional Requested Amount: \$240,000; New Award Amount: \$803,891; Awarded Vendor(s): Florida Association of Rehabilitation Facilities/Respect of Florida; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
The District utilizes exam gloves in many capacities including but not limited to brushing teeth and medical procedures in the classroom. Procurement & Warehousing Services current method for procuring these items is a piggyback off the State of Florida's contract, RESPECT 914-000-10 that expires on July 12, 2020. This request is to approve the recommendation for additional spending authority to cover expenses through its expiration.

FINANCIAL IMPACT:
The estimated financial impact to the District will be \$240,000. The contract amount was for \$563,891.
