Approve the recommendation to award additional vendors for the above Invitation to Bid (ITB). Contract Term: October 4, 2017 through June 30, 2020, 2 Years, 9 Months; User Department: District-wide; Award Amount: \$750,000; Additional Awarded Vendor(s): 8; Small/Minority/Women Business Enterprise Vendor(s): None. SUMMARY EXPLANATION AND BACKGROUND:

This request is to award additional vendors to ITB 18-013R that was approved at the Regular School Board Meeting on June 13, 2017. The School Board of Broward County, Florida, received nine (9) bids from motor coach/charter bus companies interested in pre-qualifying to provide coach transportation services. Eight (8) companies are being recommended for award to prove extra-curricular transportation services to transport students, staff, chaperones, and advisors, etc., to and from athletic, scholastic events, field trips, and grad night.
