SUMMARY EXPLANATION AND BACKGROUND: The School Board of Broward County, Florida, received three (3) bids in response to ITB 17-162F. This Bid will be utilized mainly by Physical Plant Operations (PPO) to install new fencing material and replace existing fencing throughout the District.
