## **EXECUTIVE SUMMARY**

## Recommendation for Award Additional Vendors 18-014R-1 – School Bus Transportation Services

This request is to approve the recommendation to award Invitation to Bid (ITB) 18-014R-1 School Bus Transportation Services for two (2) years and ten (10) months from September 27, 2017 through June 30, 2020. This ITB was advertised to add additional vendors to the original ITB 18-014R School Bus Transportation Services. ITB 18-014R - School Bus Transportation Services, Section 4, Special Conditions 1 states, "SBBC reserves the right to increase the pool of school bus companies to provide the services included in the ITB if deemed necessary by SBBC. Subject to approval, additional providers may be added to the pool of awarded bus companies. Regardless as to the year, a bus company is added to the pool of awarded coach bus companies; all awards will be terminated at the end of this ITB". ITB 18-014R was approved on June 13, 2017, Regular School Board Meeting (RSBM).

The School Board of Broward County, Florida, received three (3) responses to the ITB 18-014R-1 School Bus Transportation Services. School bus transportation services are utilized by various schools to provide extracurricular transportation services to transport students, staff, chaperones, and advisor to and from athletic and scholastic events and field trips.

The solicitation for the ITB 18-014R-1 was advertised on August 14, 2017, with a due date of August 24, 2017. Three (3) bids met the requirements of the ITB and are recommended for award; A & S Transportation, Inc., Franav, LLC, d/b/a Always on the Go, and World of Kids Transportation Corp. The additional three (3) vendors awarded under this ITB will provide the District with a total of six (6) vendors awarded to provide school bus transportation service.

The total contract award amount for 18-014R and 18-014R-1 is \$2,100,000. The spending authority was approved by the School Board at the June 13, 2017, RSBM. There is no additional request for spending authority for this item.
