Revised Temporary Salary Schedule Rates for the Adult Career Technical Education (CTE) and Adult General Education (AGE) Teachers

REQUESTED ACTION:
Adopt the Revised Temporary Salary Schedule Rates for the Adult Career Technical Education (CTE) and Adult General Education (AGE) Teachers.

SUMMARY EXPLANATION AND BACKGROUND:
The Temporary Salary Schedule is being updated to reflect a 3.5% increase to the hourly rate for Adult Career Technical Education (CTE), and the Adult General Education (AGE) teachers, retroactive to July 1, 2016. FINANCIAL IMPACT:
The cost to adjust the temporary rates for Adult Career Technical Education (CTE) and Adult General Education (AGE) teachers, is estimated at \$253,495.30, inclusive of 18% fringe. Dollars to fund this initiative have been earmarked as part of the Workforce Education District Reserve Fund and represents no additional expense for the District.
