<b>SUMMARY EXPLANATION AND BACKGROUND:</b> On September 1, 2015, the Broward County Commissioners approved funding recommendations made by the Broward County Behavioral Health Services (Children's Services Administration Section [CSAS]) for The School Board of Broward County, Florida Family Counseling Program (FCP) to receive a grant in the amount of \$1,343,940 with a two-year renewal option. This agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. This agreement will be executed by Broward County Behavioral Health Services after School Board approval.
