<p>The Head Start/Early Head Start grant requires the delivery of comprehensive dental service to all students enrolled in the program. These services support children to get the most out of their education by meeting some of their basic needs. The State of Florida, Department of Health agrees to continue to provide comprehensive dental health services consisting of examination, treatment, and care to the Head Start and Early Head Start children in accordance with the Department of Health and Human Services regulations. This contract will provide dental service to all non-Medicaid eligible children participating in the Head Start/Early Head Start Program throughout the 2017-2018.</p> <p>This agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.</p>
