**REQUESTED ACTION:**

Approve the recommendation to award for the above District-wide services contract. The income generated from the 3-year, 3-month contract awarded to six (6) vendors, is from September 17, 2014 through December 31, 2017. There were two (2) M/WBE awarded vendors: Double R Vending d/b/a American Healthy Vending d/b/a (Hispanic-American male), and Gilly Vending, Inc. (Hispanic-American female).

**SUMMARY EXPLANATION AND BACKGROUND:**

The School Board of Broward County, Florida, received seven (7) bids for 15-051T - Healthy Vending Program - Pre-Approval of Vendors. All bidders were asked to match the commission rates and vend pricing of the bidder who offered the highest commission, in order to be in the pool of Awardees. All bidders, except one company, were able to do so. The pool of awarded vendors consists of six (6) vendors. The various locations will be able to select their vending provider from the pool of Awardees.
