As part of the support for the overall Gulfstream project, Broward County Children's Services Administration is allocating \$100,000 to fund an administrator for the site. This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. Broward County will sign this agreement following the School Board approval.
