GENERAL OVERVIEW:

RFQ 18-038C was advertised on DemandStar on June 22, 2017. This item is for Board approval of the Professional Services Agreement between The School Board of Broward County, Florida and Nyarko Architectural Group, Inc., for professional design services for Package A: Dillard Elementary School, Park Lakes Elementary School, Maplewood Elementary School, and Liberty Elementary School.

The following project scopes were approved in the September 6, 2017, Adopted District Educational Facilities Plan and in the District's Capital Budget.

Package A: Park Lakes Elementary School Total Funds Allocated \$774,000:

Provide Professional Design Services for Park Lakes Elementary School

Design Professional shall develop a complete set of design documents that can be permitted for construction, along with construction contract administration services. The design documents scope for this project includes, but not limited to, fire sprinklers, music room renovation, conversion of existing space to music and/or art lab(s), art room renovation and equipment, building envelope improvements, and other items that may be required to execute the Board approved scope.

Package A: Maplewood Elementary School Total Funds Allocated \$362,000:

Provide Professional Design Services for Maplewood Elementary School

Design Professional shall develop a complete set of design documents that can be permitted for construction, along with construction contract administration services. The design documents scope for this project includes, but not limited to, HVAC improvements, media center improvements, and other items that may be required to execute the Board approved scope.

Package A: Liberty Elementary School Total Funds Allocated \$377,000:

Provide Professional Design Services for Liberty Elementary School

Design Professional shall develop a complete set of design documents that can be permitted for construction, along with construction contract administration services. The design documents scope for this project includes, but not limited to, music room renovation, conversion of existing space to music and/or art lab(s), PE/Athletic Improvements, HVAC improvements, and other items that may be required to execute the Board approved scope.
