Manufacturing; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received one (1) bid for ITB 18-121T. This bid will be utilized by EH&S to purchase, install and upgrade refuse compactors district-wide, to reduce the cost of waste removal, protect against pests and insect infestation, reduce environmental risks, and reduce truck traffic at our schools.
