

# **FIRST AMENDMENT TO AGREEMENT**

**THIS FIRST AMENDMENT TO AGREEMENT** is made and entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between

**THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA**  
(hereinafter referred to as "SBBC"),  
a body corporate and political subdivision of the State of Florida,  
whose principal place of business is  
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

**GLOBAL CITIES, INC.**  
(hereinafter referred to as "Global Cities"),  
having its principal place of business at  
1 Rockefeller Plaza, Suite 1134  
New York, NY 10020.

**WHEREAS**, SBBC and Global Cities entered into an Agreement dated August 8, 2017 (hereafter "Agreement"); and

**WHEREAS**, Global Cities is a non-profit organization that has developed "Global Scholars" (the "Program"), an international digital exchange program; and

**WHEREAS**, the Agreement is available to the following middle schools: Attucks, Apollo, Bair, Crystal Lakes, Deerfield Beach, Glades, Lyons Creek, Margate, Millennium, McNicol, New Renaissance, Nova, Plantation, Silver Lakes, Silver Trail, Tequesta Trace, Westglades, Westpines, and William Dandy (each, a "Site" and together, the "Sites").

**WHEREAS**, the parties mutually desire to amend certain provisions of the Agreement.

**NOW, THEREFORE**, in consideration of the premises and of the mutual covenants contained herein and the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1.01 **Recitals.** The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.

1.02 **Amended Provisions.** The parties hereby agree to the following amended provisions to the Agreement:

**The following provisions shall replace the respective provisions in the Agreement, by interlineation, as follows:**

The list of Sites in The Program is amended as follow:

Additions: Parkway Middle School, Rickards Middle School and Olsen Middle School  
Removal: Tequesta Trace Middle School

1.03 **Order of Precedence Among Agreement Documents.** In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) this First Amendment to Agreement; and
- b) the Agreement.

1.04 **Other Provisions Remain in Force.** Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

1.05 **Authority.** Each person signing this First Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment to Agreement.
