Dear Mr. Gonzalez,

We are in receipt of your letter dated January 26, 2018 and would offer the following on pricing for the three month period from 4/1/2018 and 6/30/2018.

Current pricing on full, new surfacing and resurfacing jobs shall be considered not to exceed unit pricing. Each job will be estimated on an individual basis and prices submitted based off of those estimates. As a general idea on what this would mean, facilities in excess of 5,200 square yards would more than likely see a discounted price from the unit prices in the contract.
