Recommendation to Approve Extension - 17-091F - Athletic Track - Maintenance, Repairs, Resurface and Install

REQUESTED ACTION:
Approve the extension for the above Invitation to Bid (ITB) for an additional 90 Days. New Contract Term: March 22, 2017 through June 30, 2018, 1 Year; User Department: Physical Plant Operations; Award Amount: \$1,800,000; Awarded Vendor(s): Beynon Sports Surfaces, Inc.; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
This request is to extend ITB 17-091F for three (3) additional months beyond the expiration of the current period March 22, 2017 through March 31, 2018. By extending this contract, the District will avoid disruption of services, and will allow Procurement & Warehousing Services to continue outreach efforts to pre-qualify potential and prospective bidders in order to increase participation in the upcoming and future solicitations for these services. A replacement ITB (18-146F) will be advertised in February 2018, and will remain open through May 2018, to allow non-prequalified prospective bidders, to start the pre-qualification process and be approved in time for participation.
