Approve the recommendation to award the above Invitation to Bid (ITB) - 18-139B. Contract Term: April 1, 2018 through September 30, 2019, 18 Months; User Department: Food & Nutrition Services; Award Amount: \$2,105,000; Awarded Vendor(s): 7; Small/Minority/Women Business Enterprise Vendor(s): Glocecol LLC. See Supporting Document for Continuation of Requested Action.

SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida (SBBC), received nine (9) bids for 18-139B - Paper and Plastic Items for Cafeterias. The Food & Nutrition Services department purchases various paper and plastic cafeteria items to prepare, serve, and store food.
