EXECUTIVE SUMMARY

Recommendation of \$500,000 or Greater 18-113N - Science Supplies, Equipment, Specimens, and Laboratory Chemicals (Catalog)

This request is to approve the recommendation to award Invitation to Bid (ITB) 18-113N to fourteen (14) Vendors, for three (3) years starting March 1, 2018 through March 31, 2021, with a renewal option for two (2) additional one (1) year periods. ITB 18-113N will facilitate the purchase of science supplies throughout the District and includes, but is not limited to laboratory supplies, butterfly larvae, dissection kits, microscopes, aquarium supplies, micro slides and geology models.

The solicitation ran from November 3, 2017 through November 30, 2017. There were six hundred, and sixty-four (664) vendors notified, twenty-two (22) vendors downloaded the ITB, and fourteen (14) bids were received before bid opening. Bid Item 1 was created to ensure competitive prices for the items most purchased and was awarded to the three (3) lowest responsive and responsible Bidders. Bid Item 2 was awarded to all responsive and responsible Bidders offering a discount off other web-based catalog items not included in Bid Item 1.

The previous solicitation 14-043T was awarded starting March 1, 2014 through February 28, 2018, with a spending authority of \$1,755,000.

The total spending authority requested is \$1,350,000 based on the monthly expenditure from the previous bid. The budget will be taken from various funds throughout the District.
