SUMMARY EXPLANATION AND BACKGROUND:
Computer servers purchased under this Agreement will ultimately support the needs of students, administrators, faculty, and staff. The intent is to purchase efficient and effective rack and blade server products, as well as related enterprise technology.

This Agreement will establish a contract beginning March 18, 2014, and continuing through December 31, 2018. The term of the contract may, by mutual agreement between SBBC and the Awardee, be extended for two additional one-year periods, and if needed, 180 days beyond the expiration date of the renewal period.

This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
