Recommendation for Additional Spending Authority - 14-046E - Computer Servers

REQUESTED ACTION:
Approve the recommendation for additional spending authority. Contract Term: March 18, 2014 through December 31, 2018, 4 Years, 8 Months; User Department: Information & Technology; Award Amount \$5,500,000; Awarded Vendor(s): Dell Marketing L.P.; Small/Minority/Women Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
RFP 14-046E was approved on March 17, 2014, by the School Board to purchase computer servers and services District-wide. The initial contract period is March 18, 2014 through December 31, 2018. Subsequently, two (2) requests for additional spending authority have been approved. Currently, additional servers are needed to support the Video Surveillance and Physical Security Upgrade Project (item EE-5 of this School Board Meeting).

FINANCIAL IMPACT:
The estimated financial impact to the District will be \$2,000,000. The contract award was for \$3,500,000. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the estimated contract award amount.
