**FINANCIAL IMPACT:**

Change Order #3 adds \$3,002 to the contract which is offset by the tax savings of \$1,408 with the remaining \$1,594 to come from the change order contingency. Although there is a deduction to the contract of \$21,866, the \$1,594 to come from the change order contingency is needed for \$23,460 of equipment costs for the Direct Owner Purchase.
