The financial impact of the Professional Services Agreement includes a total of \$360,000 for Basic Services, \$102,000 for Allowances, and \$75,000 for Supplemental Services for a grand total of \$537,000 for both schools ("Package B"). These projects have been appropriated in the Adopted District Educational Facilities Plan (September 6, 2017). There is no impact to the project budget.

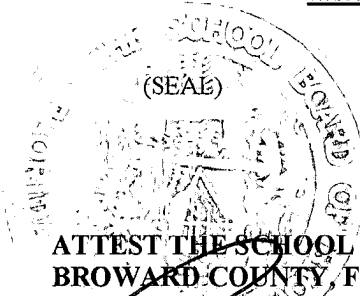




