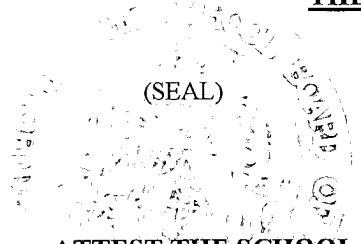

ARTICLE 11 INCORPORATION OF RFQ INTO AGREEMENT




