TITLE:

City of Hallandale Beach Community Partnership Grant Agreement

REQUESTED ACTION:

Ratify the Agreement between The School Board of Broward County, Florida (as operator of Hallandale Magnet High School), and the City of Hallandale Beach. The Agreement begins the day of School Board approval and ends on September 30, 2018.

SUMMARY EXPLANATION AND BACKGROUND:

The City of Hallandale Beach grants funds to community partnership programs that will benefit the residents of Hallandale Beach. During the City's 2018 fiscal year, the Saturday Success Academy at Hallandale Magnet High School was chosen for funding. The grant proposal was previously presented to and approved by the School Board on June 27, 2017. The subsequent grant Agreement requires School Board approval and ratification of the principal's signature. The Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
