# SUMMARY EXPLANATION AND BACKGROUND:

Florida Statute 1006.40(5) requires multiple steps in the approval process to ensure input from all stakeholders. These include:

Online access to student editions of the committee recommended instructional materials for 20 days

- An open, noticed Public Hearing during which the public may comment on the recommended instructional materials. (March 6, 2018)
- An open, noticed School Board Meeting to approve an annual instructional materials plan to identify any instructional materials that will be

purchased through the District's instructional materials review process. (March 20, 2018)

If necessary, a second Public Hearing, chaired by a Hearing Officer, to address any formal objections returned to the District regarding the adoption of these instructional materials shall be held at least 30 days following approval by the Board. (no sooner than April 20, 2018)
