REQUESTED ACTION:

Approve the addition of contracted funds from Broward County Behavior Health Services in the amount of \$134,394 for the Family Counseling Program.

SUMMARY EXPLANATION AND BACKGROUND:

<p>On September 1, 2015, the Broward County Board of County Commissioners approved funding recommendations made by the Broward County Behavioral Health Services (Children's Services Administration Section [CSAS]) for The School Board of Broward County, Florida Family Counseling Program (FCP) to receive a grant in the amount of \$1,343,940 with a two-year renewal option. The Broward County Behavioral Health Services is extending funds in the amount of \$134,394 to accommodate the current increased demand for mental health services due to the recent shooting incident.</p> <p>This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.</p> <p>This Agreement will be executed after School Board approval.</p>
