FINANCIAL IMPACT:

The financial impact of the PSA includes \$540,000 Basic Services, \$187,000 Allowances, and \$105,000 Supplemental Services totaling \$832,000. These projects have been appropriated in the Adopted DEFP FY18. \$832,000 will be accelerated from Year 5 (FY 19) to Year 4 (FY 18). This project is already planned in the General Obligation Bond (GOB), funding from the GOB will be issued sooner to coincide with the project acceleration. There is no impact to the project budget.

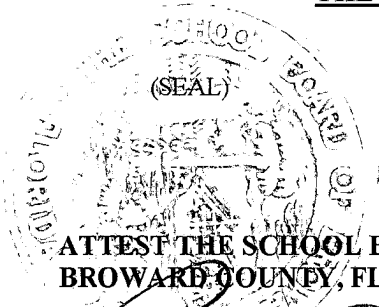

**ARTICLE 11 INCORPORATION OF RFQ INTO AGREEMENT**


