EXECUTIVE SUMMARY

Direct Negotiation Recommendation of \$500,000 or Less 58-046E – Software for Supplemental Mathematics Program

This request is to approve the Agreement between Tenmarks Education LLC and The School Board of Broward County, Florida (SBBC), for three (3) years, starting May 1, 2018 through May 31, 2021 to provide online mathematics program that personalizes learning, promotes deep conceptual understanding, and helps to raise student achievement. This Agreement will provide district-wide access at the elementary and secondary levels to a supplemental mathematics program providing teachers with additional rigorous mathematical content, including assignments, assessments, and enrichment/remediation lessons to support students in meeting the Mathematics Florida Standards.

Financial Impact

The total spending authority requested is \$173,000 based on the monthly expenditure from previous purchases. Because the program is optional, it is challenging to predict the number of schools that will participate. Therefore, the twenty (20) percent buffer used is higher than our standard ten (10) percent to account for this uncertainty.

Highlights of the system thus far include:

- Usage of the system has consistently improved with the average usage in 2017 reported at ninety-two (92) percent
- Higher usage and performance numbers have been reported for grades four five (4-5)
- High usage of Jam Sessions, which are fluency practice sessions
- Eight (8) of the twelve (12) schools that were part of the 2016-2017 pilot program chose to purchase the program for the 2017-2018 school year.
- On average, students scored three point nine (3.9) percent higher than the national TenMarks average for free and premium classes on assignments, standard level assessments, and grade level assessments.
- Performance on Grade Level Assessments was highest in grades first (1) twenty-two point nine (+22.9) percent and second (2) thirteen point eight (+13.8) percent for Elementary and grades six (6) thirty-one point five (+31.5) percent and eight (8) twenty-nine (+29) percent at the Secondary level
- Feedback from school administrators and teachers suggests that this program is aligned to classroom instruction and the rigor of the standards.
