
POSTING OF ITB RECOMMENDATION/TABULATION: Select One Recommendations and Tabulations will be posted in the Procurement & Warehousing Services and www.Demandstar.com on **MARCH 29, 2018 @ 3:00 pm** and will remain posted for 72 hours. Any person who is adversely affected by the decision or intended decision shall file a notice of protest, in writing, within 72 hours after the posting of the notice of decision or intended decision. The formal written protest shall be filed within ten (10) days after the date the notice of protest is filed. Failure to file a notice of protest or failure to file a formal written protest shall constitute a waiver of proceedings under this chapter. Section 120.57(3)(b), Florida Statutes, states that "The formal written protest shall state with particularity the facts and law upon which the protest is based." Saturdays, Sundays, state holidays and days during which the District is closed shall be excluded in the computation of the 72-hour time period provided. Filings shall be at the office of the Director of Procurement & Warehousing Services, 7720 West Oakland Park Boulevard, Suite 323, Sunrise, Florida 33351. Any person who files an action protesting an intended decision shall post with the School Board, at the time of filing the formal written protest, a bond, payable to The School Board of Broward County, Florida, (SBBC), in an amount equal to one percent (1%) of the estimated value of the contract. Failure to post the bond required by SBBC Policy 3320, Part VIII, Purchasing Policies, Section N, within the time allowed for filing a bond shall constitute a waiver of the right to protest.

(* The Cone of Silence, as stated in the ITB / RFP / RFQ / HARD BID, is in effect until it is approved by SBBC. The Board meeting date stated above is tentative. Confirm with the Purchasing Agent of record for the actual date the Cone of Silence has concluded.

AS STATED IN SPECIAL CONDITION 11:

BIDDING PREFERENCE LAWS: ALL BIDDERS MUST COMPLETE AND SUBMIT SECTION 7, ATTACHMENT 4 TO BE CONSIDERED FOR AWARD. THE STATE OF FLORIDA PROVIDES A BIDDER'S PREFERENCE FOR BIDDERS WHOSE PRINCIPAL PLACE OF BUSINESS IS WITHIN THE STATE OF FLORIDA FOR THE PURCHASE OF PERSONAL PROPERTY. THE LOCAL PREFERENCE IS FIVE (5) PERCENT. BIDDERS WHOSE PRINCIPAL PLACE OF BUSINESS IS OUTSIDE THE STATE OF FLORIDA MUST HAVE AN ATTORNEY, LICENSED TO PRACTICE LAW IN THE OUT-OF-STATE JURISDICTION, AS REQUIRED BY FLORIDA STATUTE 287.084(2), EXECUTE THE "OPINION OF OUT-OF-STATE BIDDER'S ATTORNEY ON BIDDING PREFERENCES" FORM, SECTION 7, ATTACHMENT 4, AND MUST SUBMIT THIS FORM WITH SUBMITTED BID. SUCH OPINION SHOULD PERMIT SBBC'S RELIANCE ON SUCH ATTORNEY'S OPINION FOR PURPOSES OF COMPLYING WITH FLORIDA STATUTE 287.084. FLORIDA BIDDERS ARE NOT REQUIRED TO HAVE AN ATTORNEY RENDER AN OPINION BUT THE FLORIDA BIDDER MUST COMPLETE ITS PORTION OF THIS FORM.
