Approve the renewal for the above Invitation to Bid (ITB). Contract Term: June 18, 2015 through June 17, 2019, 4 Years; User Department: Environmental Health & Safety (EHS); Award Amount: \$750,000; Awarded Vendor(s): All Liquid Environmental Services, LLC d/b/a Johnson Environmental Services and Shenandoah General Construction Company; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
This request is to renew ITB 15-106C - Storm Sewer & Sewer Main Cleaning, for one (1) additional year, June 18, 2018 through June 17, 2019, as per Bid Special Condition 5, Contract Renewal which states that: "The term of the bid shall be for three (3) year(s), and may, by mutual agreement between The School Board of Broward County, Florida, and the Awardee, be renewed for two (2) additional one (1) year periods."
