Recommendation for Additional Spending Authority -- 57-039E -- Blackboard Web Community Manager

REQUESTED ACTION:
Approve the recommendation to increase the spending authority for Blackboard Web Community Manager. Contract Term: December 21, 2016 through December 20, 2019, 3 Years; User Department: Information & Technology; Additional Requested Amount \$5,850; New Award Amount: \$337,825; Awarded Vendor(s): Blackboard Inc.; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, originally approved Schoolwires on December 20, 2016 (agenda item EE-20) with a spending authority of \$331,975. Due to a calculation error, the original spending authority request is insufficient for the term of the Agreement. The original spending authority should have been \$337,825 leaving a \$5,850 shortfall.

FINANCIAL IMPACT:
The estimated financial impact to the District will be \$337,825. The contract award amount was for \$331,975. The request is to increase the spending authority by \$5,850, bringing the new contract value to \$337,825. The funding source will come from the Information & Technology Operating Budget. The financial amount represents an estimated contract value; however, the amount authorized will not exceed the estimated contract award amount.
