Recommendation of \$500,000 or Less - ITB 18-214R - Remanufactured Engines

REQUESTED ACTION:
Approve the recommendation to award for the above Invitation to Bid (ITB). Contract Term: May 9, 2018 through May 31, 2021, 3 Years; User Department: Student Transportation and Fleet Services(STFS); Award Amount: \$440,000; Awarded Vendor(s): Jasper Engines Exchange, Inc. d/b/a Jasper Engines & Transmissions; Matthews Bus alliance, Inc.; Rechten International Trucks, Inc.; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received five (5) bids in response to ITB 18-214R. This Bid will be utilized by STFS to maintain the fleet of buses throughout the District. The estimated number of buses currently being maintained is 1327, however, this Bid will be primarily utilized to support buses with older engines.
