REQUESTED ACTION:
Approve the recommendation to award the above Invitation to Bid (ITB). Contract Term: May 23, 2018 through May 22, 2021, 3 Years; User Department: Physical Plant Operations (PPO); Award Amount: \$2,600,000; Awarded Vendor(s): Atlantic Southern Paving and Sealcoating, LLC; Pence Sealcoating Corporation; Signature Contracting & Property Management, LLC; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received three (3) bids in response to ITB 18-123C. This Bid will be utilized by PPO-Custodial/Grounds Department throughout the District, to provide asphalt, paving, resurfacing and striping services for repair and maintenance of parking lots, driveways, sidewalks, signs, play courts, and other paved surfaces in a safe and operating condition within the District.
