**SUMMARY EXPLANATION AND BACKGROUND:**  
The educational product provided by Jigsaw Learning, LLC is a blend of computer and teacher-led instruction for students with more intensive needs and is in alignment with the Florida School Readiness Performance Standards for three (3) to five (5) year-old children, as well as the Florida Early Learning and Developmental Standards.  
This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
