SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida (SBBC), received nineteen (19) bids for ITB 18-171F - Construction Services Emergency Projects (CSEP). These awards establish multiple Continuing Contracts for Construction Services Emergency Projects in accordance with the bidding documents in an effort to create a pool of pre-qualified contractors to respond only in the event of a declared emergency.

These Agreements have been reviewed and approved as to form and legal content by the Office of the General Counsel.

FINANCIAL IMPACT:

The Executive Summary and the Recommendation Tabulation provide a "not to exceed limits" clause. The total payments shall not exceed the limits of \$2,000,000 to \$50,000,000 as detailed in Exhibit 2. In the event of a declared emergency, funding for these services would come from the District reserves and staff would seek reimbursements from the Federal Emergency Management Agency, the District's excess insurance carriers, or other appropriate agencies.
