Recommendation of \$500,000 or Greater - 18-211T - Water Treatment Chemicals

**REQUESTED ACTION:**  
Approve the recommendation to award for the above contract. Contract Term: July 1, 2018, through June 30, 2021, 3 Years; User Department: Physical Plant Operations (PPO); Award Amount: \$1,300,000; Awarded Vendor(s): Premier Water & Energy Technology, Inc. and SWE, Inc, D/B/A Southwest Engineers; Small/Minority/Women Business Enterprise Vendor(s): None.

**SUMMARY EXPLANATION AND BACKGROUND:**  
The School Board of Broward County, Florida, received three (3) bids for 18-211T - Water Treatment Chemicals. This Bid will be utilized by PPO to provide regular maintenance to Heating, Ventilation, and Air Conditioning (HVAC) systems. The performance of routine maintenance to Air Conditioning chillers, air handler units, cooling towers, and related pumps and pipes are essential to prevent scale, corrosion, or micro-biological growth within HVAC systems.
