REQUESTED ACTION:
Approve the application for Florida Charter School Organization, Inc., (Championship Academy of Distinction at Broward), to open a charter school serving grades K-8 for the 2019-2020 school year and authorize the Superintendent to issue a notice of approval. Subsequent School Board approval shall be required prior to the signing of a written charter school agreement establishing the operation of the charter school.
