On April 9, 2013, The School Board of Broward County, Florida, approved a Charter School Agreement authorizing Greentree Prep Charter School, Inc., to open Greentree Preparatory Charter School – 5130. The original contract was effective for a five-year period, to conclude on June 30, 2018.

Pursuant to Section 1002.33(8)(b), Florida Statutes, a school's Charter School Agreement may be renewed subject to a program review and provided that none of the statutory grounds for non-renewal have been documented.

The Superintendent's Charter School Review Committee has reviewed and analyzed the Charter Renewal Process submitted by Greentree Prep Charter School, Inc., (Greentree Preparatory Charter School – 5130), and has recommended a renewal of its Charter Agreement.

The Sponsor has conducted annual reviews of the charter school's academic progress, operational performance and financial viability, and concurs with the State's designation of high-performing charter school.

The Superintendent's Charter School Review Committee has reviewed and analyzed the Charter Renewal Program Review submitted by Greentree Prep Charter School, Inc., (Greentree Preparatory Charter School – 5130), and has recommended a renewal of its Charter Agreement.

Greentree Prep Charter School, Inc., (Greentree Preparatory Charter School – 5130), desires to include the charter school's designation as a high-performing charter school in the Charter School Agreement and receive a fifteen-year renewal pursuant to Section 1002.331, Florida Statutes. The School also, desires to increase its grade level configuration to include grades 6 – 8. Greentree Prep Charter School, Inc.

It is requested that The School Board of Broward County, Florida, approve the renewal of the Charter School Agreement for Greentree Prep Charter School, Inc., (Greentree Preparatory Charter School – 5130), for a fifteen-year period starting on July 1, 2018 and ending on June 30, 2033.

Greentree Preparatory Charter School – 5130, is located at 6301 SW 160<sup>th</sup> Avenue, Southwest Ranches, Florida 33331, which is located in District 2.
