REQUESTED ACTION:
 Recommendation to Approve an increase in spending authority for the above Invitation to Bid (ITB). Contract Term: August 16, 2016 through August 31, 2019, 3 Years; User Department: Environmental Health and Safety; Additional Requested Amount: \$2,000,000; New Award Amount: \$3,800,000; Awarded Vendor(s): Decon Environmental & Engineering, Inc.; Prism Response, Inc.; Simpson Environmental Services, Inc.; Small/Minority/Women Business Enterprise Vendor(s): Decon Environmental & Engineering, Inc.

SUMMARY EXPLANATION AND BACKGROUND:
 The School Board of Broward County, Florida, received three (3) proposals in response to ITB 16-128F - Miscellaneous Asbestos and Mold Abatement. FINANCIAL IMPACT:
 The estimated financial impact to the District will be \$2,000,000. The contract award amount was for \$1,800,000. The request is to increase the spending authority by \$2,000,000, bringing the new contract value to \$3,800,000. The funding source will come from the Safety, Music & Art, Athletics, Renovation and Technology (SMART) budget. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the contract award amount.
