Recommendation for Additional Spending Authority - 16-158C - Miscellaneous Environmental Consulting Services

REQUESTED ACTION:
Approve an increase in spending authority for the above Request for Proposal (RFP). Contract Term: December 1, 2016 through November 30, 2019, 3 Years. User Department: Environmental Health and Safety; Additional Requested Amount: \$580,000; New Award Amount: \$1,580,000; Awarded Vendor(s): Air Quest Environmental, Inc.; ECO Advisors, LLC; EE & G Environmental Services; LLC; GLE & Associates, Inc.; Professional Services Industry, Inc.; Small/Minority/Women Business Enterprise Vendor(s): Air Quest Environmental, Inc.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received eight (8) proposals in response to RFP 16-158C - Miscellaneous Environmental Consulting Services. The awarded vendors will provide environmental services such as testing, sampling, performing hazard assessments and other consulting services for asbestos, lead based paint, mold, indoor air quality, and additional industrial hygiene services.

FINANCIAL IMPACT:
The estimated financial impact to the District will be \$580,000. The contract award amount was for \$1,000,000. The request is to increase the spending authority by \$580,000, bringing the new contract value to \$1,580,000. The funding source will come from the Safety, Music/Arts, Athletics, Renovations & Technology (SMART) budget. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the contract award amount.
