**REQUESTED ACTION:**  
Approve the recommendation to renew and increase the spending authority for the above Piggyback. Contract Term: July 2, 2016 through July 1 2019; 3 Years; Physical Plant Operations; Additional Requested Amount: \$80,000; New Award Amount: \$320,000; Awarded Vendor(s): Melrose Supply & Sales Corp., Quigar Electric, Inc. d/b/a Ace Pump & Supply, Rise Pump and Motor Repair, Inc., SiteOne Landscape Supply, LLC; Small/Minority/Women Business Enterprise Vendor(s): None.

**SUMMARY EXPLANATION AND BACKGROUND:**  
This represents the first renewal of this Piggyback that is used by the Physical Plant Operations Department (PPO) and provides a catalog discount off different manufacturers of irrigation supplies.
