On June 11, 2013, The School Board of Broward County, Florida, approved a Charter School Agreement authorizing Somerset Academy, Inc., to open Somerset Academy Hollywood – 5387. The original contract was effective for a five-year period, to conclude on June 30, 2018.

On July 28, 2015, The School Board of Broward County, Florida approved the change of location and colocation with Somerset East Preparatory – 5391.

Pursuant to Section 1002.33(8)(b), Florida Statutes, a school's Charter School Agreement may be renewed subject to a program review, provided that none of the statutory grounds for non-renewal has been documented.

Additionally, the School desires to relocate again and wishes to change its name from Somerset Academy Hollywood to Somerset Riverside Charter School – 5387. The school also desires to increase its contract enrollment capacity to align with the new facility.

The Superintendent's Charter School Review Committee has reviewed and analyzed all components of the charter renewal program review submitted by Somerset Academy, Inc., (Somerset Riverside Charter School – 5387), and has recommended a renewal of its Charter Agreement.

Pursuant to Section 1002.33(7)(b)1, Florida Statutes, a charter may be renewed provided that a program review demonstrates that the criteria in paragraph (a) have been successfully accomplished and that none of the grounds for nonrenewal established by paragraph (8)(a) has been documented. The Superintendent's Charter School Review Committee has thoroughly reviewed all components of the charter renewal program review and determined that it meets the renewal criteria.

It is requested that The School Board of Broward County, Florida, approve the renewal of the Charter School Agreement for Somerset Academy, Inc. (Somerset Riverside Charter School – 5387), for a five-year period starting on July 1, 2018 and ending on June 30, 2023.

Somerset Riverside Charter School – 5387, will be located at 2251 Riverside Drive, Coral Springs, Florida 33065, located in District 4.

The governing board members of Somerset Academy, Inc., reside in Miami-Dade County, Florida.
