**TITLE:**  
Agreement with Whole Kids Foundation

**REQUESTED ACTION:**  
Approve the Agreement(s) between The School Board of Broward County, Florida, and Whole Kids Foundation. The Agreement begins the day of School Board approval. While the Foundation does not specify an end date or a period end date by which all the funds must be used, the Broward Youth Treatment Center intends to spend the funds within one year of Board approval.

**SUMMARY EXPLANATION AND BACKGROUND:**  
Whole Kids Foundation has awarded the Broward Youth Treatment Center a grant of \$2,000. Grant funds will be used to establish an edible garden at the center. Students will harvest crops, learn to cook from garden produce, and enjoy eating and sharing healthy vegetable dishes. The grant was approved by the School Board on April 10, 2018.  
The Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
