REQUESTED ACTION:

Approve the Agreement with Carlton Palms Educational Center, Inc. d/b/a Bellwether Behavioral Health. Contract Term: July 1, 2018 through June 30, 2019; 1 Year; User Department: Exceptional Student Learning Support; Award Amount: \$40,000; Awarded Vendor(s): Carlton Palms Educational Center, Inc. d/b/a Bellwether Behavioral Health; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:

Florida Administrative Code 6A 6.0361, Contractual Agreements with Non-Public Schools allows for Broward County Public School (District) to contract with a residential facility when another public agency has placed the student for non-educational purposes.
