EXECUTIVE SUMMARY

Recommendation of \$500,000 or Less School Resource Officer (SRO) Program Agreements for 2018/2019

This request is to approve the School Resource Officer (SRO) Program Agreement for the City of Margate, with a spending authority of \$208,000. The contract term is for ten (10) months from August 08, 2018 through June 05, 2019. The current agreement for 2017/2018 had a contract term for ten (10) months, from August 14, 2017 through June 7, 2018.

The SRO Program is a joint venture between The School Board of Broward County, Florida, and City of Margate law enforcement agency in Broward County. The SRO Program serves to enhance the relationship between law enforcement and the students of Broward County Public Schools by assigning Police Officers to serve as resource officers at schools. The SRO perform multiple duties within a school including, without limitation to:

- a) The performance of law enforcement functions within the school setting.
- b) The identification and prevention of juvenile delinquency (including substance abuse) through counseling and referral services.
- c) The enhancement of student knowledge of the law enforcement function and of the fundamental concept and structure of law.
- d) The development of positive student concepts of the law enforcement community and promotion of positive interaction and enhanced relations between students and law enforcement officers.
- e) The provision of assistance and support for crime victims (including victims of abuse) identified within the school setting.
- f) The presentation of educational programs concerning crime prevention, the rights, obligations, and responsibilities of students as citizens.
- g) The provision of assistance to the District in protecting and securing the school plant and its occupants.

The program emphasis focusing on developing a rapport with students, presenting information to students on various crime prevention subjects, providing law enforcement resource assistance to school personnel, parents, students, identifying, and counseling youths, thereby diverting them from the juvenile justice system. Through these activities, the SRO program helps students, parents, and educators develop a better understanding of the role of the law enforcement officer and create a more positive concept of our legal and judicial system.

Financial Impact

The estimated financial impact to the District will be \$208,000 for four (4) SROs. The funding source will come from the District's Special Investigative Unit's operating budget.

The financial impact represents an estimated contract value; however, the amount authorized will not exceed the estimated contract award amount.
