Agreement between Healthy Schools, LLC and The School Board of Broward County, Florida

REQUESTED ACTION:

Approve the agreement with Healthy Schools, LLC and The School Board of Broward County, Florida (SBBC) to improve student health and reduce absenteeism, by providing health related services (e.g. vaccination programs and adolescent wellness checks (physical) from Healthy Schools.

SUMMARY EXPLANATION AND BACKGROUND:

<p>According to the Center for Disease Control (CDC), influenza (flu) is more dangerous than the common cold for children. Children with chronic health conditions are especially at high risk of developing serious complications from the flu which can result in hospitalization or death. Healthy Schools, LLC through its licensed health care workers, will provide vaccination services, including the influenza vaccine, TDAP vaccine at NO cost to students in SBBC with written parental/guardian consent. Healthy Schools, LLC will perform comprehensive child health check-ups (physical) for students (ages 12-19) who have not had a physical in 12 months or more and are Medicaid eligible at NO cost with written parental/guardian consent.</p> <p>See Supporting Docs for continuation of Summary Explanation and Background.</p> <p>This agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.</p>
