WHEREAS, the School Board of Broward County, Florida is an educational institution receiving funding from the Federal DOE;

**RESOLUTION IN SUPPORT OF ATTENDANCE AWARENESS MONTH
SEPTEMBER 2018**

WHEREAS, good attendance is essential to student achievement and graduation, and we are committed to dedicating our resources and attention to reducing chronic absenteeism rates, with a focus starting as early as prekindergarten and kindergarten; and

WHEREAS, chronic absenteeism is identified as a student that is absent for 10 percent or more of school days for any reason, including excused and unexcused absences. Just two or three days a month is a proven predictor of academic trouble and dropout rates; and

WHEREAS, improving attendance rates and reducing chronic absenteeism in a community takes commitment, collaboration, and tailored approaches to barriers and strengths in each community; and

WHEREAS, the impact of chronic absence hits low-income students and children of color particularly hard if they do not have the resources to make up for lost time in the classroom and are more likely to face systemic barriers to getting to school; and

WHEREAS, chronic absence can be significantly reduced when schools, families, and communities work together to monitor and promote good attendance and address hurdles that keep children from getting to school; and

WHEREAS, schools and community partners can more frequently attempt to engage absent students to determine what barriers they face to attending school and what would help them attend more regularly; and

WHEREAS, health care providers and school nurses can share the importance of school attendance with families and can offer proactive, preventive care to reduce absences; and

WHEREAS, schools and districts must do more to track, calculate, and share the data on how many students are chronically absent so that we can see the attendance gaps and can deliver the right interventions to the right students;

NOW, THEREFORE, BE IT RESOLVED, that The School Board of Broward County, Florida, in conjunction with students, parents, educators, school social workers, health care agencies, social service agencies, and community partners, hereby declares:







AS NATIONAL HOMELESS YOUTH AWARENESS MONTH**

WHEREAS, on July 11, 2007, both the United States House and the Senate passed a resolution declaring November, National Homeless Youth Awareness Month; and

WHEREAS, according to Education for Homeless Children and Youth sub-grant data 2015-2016, compiled by the National Center for Homeless Education, more than 1.3 million children and youths were identified across the united states as homeless; and

WHEREAS, over 72,000 school-aged children and youths were identified as homeless in the state of Florida during the 15-16 school year; and

WHEREAS, in Broward County Schools, 4931 students were identified as homeless during the 17-18 school year reflecting a 79% increase over SY16-17

WHEREAS, of the 4931 students identified, 3% attended pre-school; 52% attended elementary school, 20% attended middle school and 25% attended high school and centers, and 387 students were unaccompanied in that they did not reside with a parent or legal guardian; and

WHEREAS, of the 4931 students identified, 242 were unsheltered; 581 resided in motels and hotels; 450 resided in temporary shelters; and 3653 resided doubled-up out of economic necessity or similar situation; and

WHEREAS, youths of color, lesbian, gay, bisexual, transgender, queer and questioning (LGBTQ) students are disproportionately represented within the homeless youth population; and

RESOLUTION IN SUPPORT OF CONCUSSION MANAGEMENT PROTOCOLS INCLUDING NEUROCOGNITIVE TESTING FOR HIGH SCHOOL STUDENT ATHLETES

WHEREAS, a concussion is a disturbance in brain function that occurs following either a blow to the head, face, or neck or as a result of the violent shaking of the head or body; and

WHEREAS, a concussion resulting from playing in interscholastic sports may result in the rapid onset of neurological impairment and acute clinical symptoms such as chronic headache, fatigue, mental sluggishness, sleep difficulties, personality changes (e.g. increased irritability), sensitivity to light or noise, dizziness, and coordination difficulties as well as deficits in short term memory, concentration, problem solving, and general academic functioning that reflect a functional neurological disturbance; and

WHEREAS, the incidence of concussion leaves student-athletes vulnerable to conditions such as Second Impact Syndrome, which can result in death or permanent disability, or Post-Concussion Syndrome, which involves thinking, behavioral, and emotional difficulties that can last up to weeks, months, or even years after injury to the brain, should a student-athlete sustain a second concussion prior to the complete resolution of the primary injury; and

WHEREAS, the School Board of Broward County implements a series of concussion management protocols designed to prevent and manage concussions including the implementation of baseline and post injury neurocognitive testing; and

WHEREAS, concussion management protocols include:

- Annual pre-participation physical for all student athletes with medical history requirements on head injuries, concussions, severe headaches, tingling in extremities and memory loss,
- Agreement with Memorial Healthcare to provide state/nationally certified athletic trainers at all twenty-nine high schools. Athletic trainers serve as first responders for sports medicine issues including concussions,
- Adhere to Florida High School Athletic Association rule that any athlete who exhibits signs, symptoms or behaving consistent with a concussion (such as loss of consciousness, headache, dizziness, confusion or balance problems) shall be immediately removed from the contest or practice and shall not return to play until cleared by an appropriate health care professional,
- All head coaches and student athletes are required to view the online education course, "Concussion in Sports-What You Need to Know." An affidavit of compliance for the concussion course must be maintained by each high school and signed by the school principal and athletic director,

- Contest officials shall be cognizant of athletes who display signs, symptoms or behaviors of a concussion and immediately stop play for injury evaluation within the rules of the game. Once the patient has been removed from a contest due to a suspected concussion, the coach, athletic trainer and appropriate health care professional shall assume full responsibility for that athlete's evaluation and safety. The national certified athletic trainer will assist with sideline evaluation of a student athlete when the athlete is sent out of a game or practice,
- High school football players must sit out one play if their helmet comes off unless a penalty was issued,
- All student athletes participating in interscholastic sports shall be required as a participating condition to take a baseline neurocognitive test. Neurocognitive tests which are brief, computer-administered, neurocognitive screening devices developed by experts in the field of sport-related concussion, scientifically validated to measure the effects of concussive injuries, and designed to help clinicians evaluate an athlete's recovery following concussion by assessing aspects of an athlete's cognitive functioning such as working memory, sustained and selective attention and reaction time, can be used to help objectively evaluate a concussed athlete's post injury condition and track their recovery for a safe return to play and thereby help to prevent or minimize the cumulative effects of concussion,
- Three NCAA parent eligibility nights sponsored by the Department of Sports Medicine at Nova Southeastern University, Memorial Healthcare and the Broward County Athletic Association will be held this Fall. Parents and students will have the opportunity to interact with staff around concussion symptoms and overall health awareness,
- No athlete shall return to play or practice on the same day of a suspected concussion,
- Any athlete suspected of having a concussion shall be evaluated by an appropriate health care professional,
- Any athlete with a suspected concussion shall be medically cleared by an appropriate health care professional prior to resuming participation in any practice or competition,
- After medical clearance, return to play shall follow a graduated protocol with provisions for delayed return to play based upon the return of any signs or symptoms,
- Adhere to National Operating Committee on Standards for Athletic Equipment (NOCSAE) to annually recondition every football helmet,
- Limit the lifespan of helmets to five years, and destroy all helmets after the five-year period,
- Every student athlete and parent shall be required to read and sign Consent and Release from Liability Certificate for Concussions. Such certificate produced by the Florida High School Athletic Association shall educate parents and athletes on signs and symptoms of a concussion and action steps that must be taken; and


WHEREAS, the School Board of Broward County supports a comprehensive education campaign to increase awareness about concussion management, including prevention, symptoms and treatment developed with the assistance of Memorial Healthcare, Nova Southeastern University, booster clubs and community organizations such as the Daniel Brett Foundation; and



WHEREAS, the Florida Legislature passed Florida Statute 383.50, *Treatment of Abandoned Newborns*, the Safe Haven Law, in July, 2000. Subsequently, in 2001 the Gloria M. Silverio Foundation, a 501(c)3 Florida not-for-profit organization, started the first major project, "A Safe Haven for Newborns", in response to the tragedy of newborn abandonment in Florida; and

WHEREAS, the Foundation started in Miami and today, through public awareness efforts, is in all 67 Florida counties, partnering with the Florida Fire Chiefs Association, Emergency Medical Services, many hospitals and other organizations and agencies throughout the State of Florida; and

WHEREAS, Florida law states that a birth parent (mother or father) may anonymously leave an infant approximately seven days old or younger, and who does not appear to be abused or neglected, in the hands of staff at a fire station or hospital, letting that person know they are leaving the baby in a "safe haven", without fear of being arrested or charged with abandonment; and

WHEREAS, many hospital emergency rooms, fire stations, and ambulance stations have a sign identifying their building as a "Safe Haven for Newborn Station"; and

WHEREAS, the lifeline of the organization is the 24/7 statewide multilingual helpline, 1-877-767-BABY (2229), which was initially created to assist young mothers who were considering the "Safe Haven" option or wanted to know more about the law; and the organization has grown into helping pregnant girls/women or mothers in crisis or need covering a wide variety of issues; and the website <http://www.asafehavenfornewborns.com> has been established to assist in accessing information; and

WHEREAS, as of today over 277 babies have been saved from abandonment in the State of Florida; over 5,000 mothers have been assisted in their time of need or crisis; 65 mothers, their anonymity not a concern, chose to place their baby directly with a licensed adoption agency, 5 parents successfully regained their parental rights; and 4 newborns were saved from abandonment in other states, securing their future; and







WHEREAS, Broward County Public Schools has made notable efforts to preserve and infuse the history of Africans and African-Americans in its curriculum, its classrooms, and in its support of African-American heritage, including its support of the Old Dillard Museum, a site listed on the National Register of Historic Places as the first public schoolhouse for Blacks in Broward County; and

WHEREAS, children enter the foster care system for a variety of reasons such as substance abuse, mental illness, domestic violence, physical abuse, and/or neglect; and

WHEREAS, a child entering the foster care system must confront the widespread misperception that children in foster care are disruptive, unruly, and dangerous, even though placement in the foster care system is based on the actions of a parent or guardian; and

WHEREAS, the primary goal of the foster care system is to ensure the safety and well-being of children while working to provide a safe, and loving home for each child; and

WHEREAS, children of color are disproportionately represented in the foster care system and are less likely to be reunited with their biological families; and

WHEREAS, on average, there are almost 2,000 Broward County children living in foster care; and

WHEREAS, the average child in the foster care system is 10 years old, and will be placed in 3 different homes, leading to separations from siblings, and unfamiliar surroundings; and

WHEREAS, most children who remain in foster care without a placement with a permanent family struggle to prevent homelessness, unemployment, teen pregnancy, substance use, and involvement in human trafficking, and

WHEREAS, there is a dire need for more out of home care placements in Broward County, Florida.


