Recommendation to Approve First Amendment to Agreement - 16-017V - Consulting Services for Employee Benefits Program

**REQUESTED ACTION:**  
Approve the First Amendment to Agreement for the above-referenced Request for Proposal (RFP). Contract Term: January 1, 2019 through December 31, 2019, 1 Year; User Department: Benefits; Award Amount: \$550,000; Awarded Vendor(s): Gallagher Benefit Services, Inc.; Small/Minority/Women's Enterprise Vendor(s): HP Office Products, Inc.; S. Davis and Associates, P.A.

**SUMMARY EXPLANATION AND BACKGROUND:**  
The contract for RFP 16-017V - Consulting Services for Employee Benefits Program was awarded to Gallagher Benefit Services, Inc. on August 18, 2015. The term of the initial contract period was January 1, 2015 through December 31, 2017, with an option for two (2) one (1) year renewals. This request is to approve the First Amendment to Agreement. The first renewal contract term is January 1, 2019 through December 31, 2019.  
The First Amendment to the Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.

**FINANCIAL IMPACT:**
