REQUESTED ACTION:

Approve the First Amendment to Agreement for the above-referenced Request for Proposal (RFP). Contract Term: January 1, 2019 through December 31, 2019, 1 Year; User Department: Benefits Department; Award Amount: \$550,000; Awarded Vendor: Gallagher Benefit Services, Inc.; Small/Minority/Women Business Enterprise Vendor: S. Davis & Associates, P.A.

SUMMARY EXPLANATION AND BACKGROUND:

The contract for RFP 16-017V - Consulting Services for Employee Benefits Program was awarded to Gallagher Benefit Services, Inc. on August 18, 2015. The term of the initial contract period was October 1, 2015 through December 31, 2018, with an option for two (2) one (1) year renewals. See Supporting Docs for continuation of Summary Explanation and Background. This First Amendment to Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
