Recommendation of \$500,000 or Greater - 19-050B - Appliances, Commercial Equipment, Supplies and Parts (CATALOG)

REQUESTED ACTION:
Approve the recommendation to award for the above Invitation to Bid (ITB). Contract Term: December 1, 2018 through November 31, 2020, 2 Years; User Department: District-wide; Award Amount: \$1,180,000; Awarded Vendor(s): Five (5); Small/Minority/Women Business Enterprise Vendor(s): None. See Supporting Docs for Continuation of Requested Action.

SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received five (5) bids in response to ITB 19-050B - Appliances, Commercial Equipment, Supplies and Parts (CATALOG). This ITB will be used by Schools and District locations to purchase appliances, commercial equipment and associated supplies and parts at single, fixed-percentage discounts from various manufacturer catalogs. Items that can be purchased include, for example, commercial grade refrigerators, ranges, ovens and kitchen smallwares for use in classrooms, dining areas, school clinics, cafeterias, etc.

FINANCIAL IMPACT:
