Ratify the Memorandum of Understanding between The School Board of Broward County, Florida and the Federation of Public Employees (FOPE) (Maintenance, Facilities Service, Transportation and Security Specialists/Campus Monitors) effective July 1, 2018 -- June 30, 2019.

For the 2018-2019 School Year, this Memorandum of Understanding is an agreement to give a one-time only additional ten (10) days of sick leave to eligible employees, effective July 1, 2018 as follows:
